ORDER

Government have accorded Administrative Sanction as per G.O. read as 3rd paper above for starting Coaching Centres for Muslim Youth each at Kasargode in Kasargode District and Vengara in Malappuram District in connection with the Government's 100 days programme. As per the Government Order read as 4th paper above, Government have accorded Administrative Sanction to start three more Coaching Centres at Thiruvananthapuram, Kanjirapally in Kottayam District and Pathanamthitta. The posts of Principal in the Coaching Centres at Vengara and Kasargode have already been created vide Government Order read as 5th paper above.

In this circumstances the Director, Minority Welfare Department, in his letters read as 6th above has proposed to create one Principal post each in the Coaching Centres for Muslim Youth at Thiruvananthapuram, Kanjirapally and Pathanamthitta and one post each of Computer Operator, L.D. Clerk, Peon and Casual Sweeper in the five Coaching Centres at Thiruvananthapuram, Kanjirapally, Pathanamthitta, Kasargode and Vengara and informed that the expenditure in this regard can be met from the Head of Account '2225-03-800-93 NP.'

3. Government have examined the matter in detail and are pleased to accord sanction to create the following posts in the Coaching Centres for Muslim Youth at Vengara, Kasargode, Thiruvananthapuram and Kanjirapally.
