**ORDER**

The Director, Minority Welfare Department has submitted a proposal “Reimbursement of fee for the BPL Minority students who are studying for 6 months/1 year/ 2 Year courses in Government affiliated private Industrial Training Institutes”. In the current years budget an amount of Rs.2 crore has been earmarked under the H/A. 2225-04-277-94 for the said scheme.

The Director of Minority Welfare Department as per letter read above has reported that the scheme is for the Minority students who are joining for various affiliated trades in any affiliated private ITIs (formerly known as ITCs) for affiliated courses having duration of six months/ one year / two year from the academic year 2015-16. In the absence of BPL Minority students, students from the families having annual income below 6 Lakh will be considered. The selection will be in 80:20 among Muslims and other minority communities. 10% seats will be reserved for minority girls.

The admissible rate of reimbursable fee amount and financial assistance are as follows:

Sl.No	Fee Structure	Course Duration
1	Rs.20,000/-	Two years
2	Rs.10,000/-	One year

**Financial assistance:**

1. 250 students xRs.20000 =Rs.50,00,000/-(for 2 years)
2. 1500 students xRs.10000 =Rs.1,50,00,000/-( for 1 year)

**Total Rs.200 lakhs for 1750 students**

The above amount will be given to the beneficiaries who are joining the ITCs at the above rate or actual fee paid by the beneficiary whichever is less. The selected students shall open an account in his name in a Nationalised Bank and the grant will be deposited in his account through money transfer system (RTGS). For the students having 75-100% attendance, amount will be paid in full and others will be paid proportionately. Those having minimum percentage of attendance required for appearing the board examination are not eligible for the financial assistance.

Departmental Working Group meeting held on 23.04.2015, considered and approved the above project.

In the circumstances Government have examined the proposal in detail and are pleased to accord Administrative Sanction for the project "Reimbursement of fee for the BPL Minority students who are studying for 6 months/1 year/ 2 Year courses in Government affiliated private Industrial Training Institutes" at an estimated cost of Rs. 2 crore from the plan fund under the Head of Account '2225-04-277-94' limiting the expenditure to this year's budget provision subject to the conditions of plan write up 2015-16 and the following conditions:

1. The institutions like government Engineering Colleges, Polytechnics/KASE and ITIs and KGCET may be included.
2. The fees to be given is what is actually paid or what is proposed which ever is less.
3. Department should monitor the placement of student after the course and tie up with industries for placement may be tried.

The implementation of the scheme will be monitored by the Directorate of Minority Welfare, Directorate of Employment and Training and minority section in the district collectorates.
